S. R. O. No. 159/2016.—In exercise of the powers conferred by sub-section (2) of section 6 of the Kerala Land Conservancy Act, 1957 (8 of 1958), the Government of Kerala hereby make the following amendment to the notification issued under G. O. (P) No. 50/2015/RD dated 2nd February, 2015 and published as S.R.O. No. 59/2015 in the Kerala Gazette Extraordinary No. 232 dated 2nd February, 2015, namely:—

33/693/2016/S-26.

#### AMENDMENT

In the said notification, under the Schedule, under the heading Article, in column (1), against the entries in item (a) of serial number 2, in column (2), for the symbol and figure "₹ 200", the symbol and figure "₹ 50" shall be substituted.

## **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

Government have revised the rates of compensation for destruction, removal or appropriation from Government land earth, sand, metal, laterite, lime shell and other notified articles as per notification issued under G. O. (P) No. 50/2015/RD dated 2nd February, 2015 and published as S.R.O. No. 59/2015 in the Kerala Gazette Extraordinary No. 232 dated 2nd February, 2015. The increase in compensation for all building stones, except laterite, when extracted and used for construction purpose as stones, block, metal grits, rubble, ballast etc. have affected the general public. Several requests were received from the public to reduce the enhanced rate.

Therefore Government have decided to reduce the enhanced rate of the aforementioned article from ₹ 200 per metric ton to ₹ 50 per metric ton by amending the Notification issued under G. O. (P) No. 50/2015/RD dated 2nd February, 2015 and published as S.R.O. No. 59/2015 in the Kerala Gazette Extraordinary No. 232 dated 2nd February, 2015.

The notification is intended to achieve the above object.
