**S. R. O. No. 375/2015.**—In exercise of the powers conferred by section 22 of the Mines and Minerals (Development and Regulation) Act, 1957 (Central Act 67 of 1957) and in supersession of the notification issued under G.O.(P) No. 170/2010/ID dated 4th August, 2010 and published as S.R.O. No. 824/2010 in the Kerala Gazette Extraordinary No. 1903 dated 16th August, 2010, the Government of Kerala hereby authorise the officers specified in column (2) of the Schedule below to prefer complaints in writing in courts in respect of any offence punishable under the said Act or any rules made thereunder in their respective areas of jurisdiction specified against each in column (3) thereof, namely:—

#### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

In exercise of the powers conferred by section 22 of the Mines and Minerals (Development and Regulation) Act, 1957 (Central Act 67 of 1957), the Government of Kerala have decided to authorise various officers of the Mining and Geology Department to prefer complaints in Courts under the provisions contained in the said Act and the rules so as to make the Mining and Geology Department as a Single Authority for the implementation of the rules made there under, in supersession of the existing notification issued under G.O.(P) No. 170/2010/ID dated 4th August, 2010 and published as S.R.O. No. 824/2010 in the Kerala Gazette Extraordinary No. 1903 dated 16th August, 2010.
