2. Municipalities (in respect of lands vesting in the Municipality concerned)	(1) Municipal Secretary	The area within the concerned Municipality. In all cases except for limeshell and dimension stones for which the royalty does not exceed Rs. 5,000.
	(2) Municipal Council	The area within the concerned Municipality. In all cases except for limeshell and dimension stones for which the royalty exceeds Rs. 5,000 but does not exceed Rs. 10,000.

3. Panchayats (in respect of lands vesting in the Panchayat concerned)	(1) Panchayat Secretary	The area within the concerned Panchayat. In all cases except for limeshell and dimension stones, where the royalty does not exceed Rs. 1,000.
	(2) Panchayat	The area within the concerned Panchayat. In all cases except for limeshell and dimension stones for which the royalty exceeds Rs. 1,000 but does not exceed Rs. 5,000.
4. Forest (in respect of reserved forests and other forest areas vesting in the Forest Department)	Divisional Forest Officer	The area within the concerned Forest Division. In all cases except for limeshell and dimension stones where the royalty does not exceed Rs. 10,000.
5. Mining and Geology	Director of Mining and Geology	Within the entire State (in all other cases)

For the effective implementation of the Kerala Minor Mineral Concession Rules, 1967, Government have decided to appoint various officers in the departments of Revenue, Forest and Local Bodies, to exercise the powers and perform the functions of the competent authority as defined in clause (iv) of Rule 3 thereof.
