### **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

Rule 62 of Kerala Minor Mineral Concession Rules, 1967, empowers the Government to delegate all or any of the powers vested in them to any Officer or class of Officers under them by notification in the Official Gazette. Accordingly, the Government have delegate the powers exercisable by it under sub-rule (2) of rule 58 of the said Rules to the Director of Mining and Geology. The Director of Mining and Geology finds it difficult to implement the rule effectively within the entire State of Kerala. Hence, to have effective implementation, Government have decided to delegate its power under the said rule to the Senior Geologists/Geologists.

This notification is intended to achieve the above object.
