

01	Double fly tent	14 feet X 14 feet X 8 feet high inner fly and 4 feet high side wall	6 Numbers

1. Tent should be of double fly made of double layers of cloth with overlapping pardah having lacing arrangement complete with all standard accessories
2. The four corners of the wall may be open and can be laced up
3. In the inner fly and outer fly the inner layer decorative yellow cloth and outer layer special olive green waterproof canvas
4. The tent should be supplied with Bamboo pole, Ridge, Wooden pegs, Wooden hammer , Iron pin and should be packed safely
5. Size- 14 feet X 14 feet X 8 feet inner high fly and 4 feet high side wall

OTHER GENERAL CONDITIONS

1. Execution of earlier orders in respect of similar stores with the name and addresses of customers have to be furnished.
2. The name and address of actual manufacturers, in case of intends to market on subcontract other firms product have to be mentioned in the tender.
3. The price shall be quoted on the basis of local delivery at site (Kesavadasapuram, Pattom Palace P.O., Thiruvananthapuram -695004, Kerala) and must be inclusive of all taxes and duties, transit insurance, packing and forwarding charges & freight etc
4. Non ambiguous tenders covering all request details with the comparatively prompt delivery period with firm and fixed commitment shall receive due preference in deciding the competitive offers
5. Deviation, if any from the given specification must be brought out in sufficient details and clarity by the tenderers in their respective orders
6. Any sort of import assistance in the form of import licence/foreign exchange etc will not be extended by the indenter/purchaser.
7. All delivered stores should carry 100% warranty against defects in material bad workman ship and non-conformity of industrial standards.
8. Offer validity: the offer/ rate quoted should remain till 31-03-2023
9. The store can be best quality and workmanship and comply with the contract and in all respects be to the satisfaction of the purchaser.
10. Dimensional Precision: Precision of the dimensional conformity in respect of corresponding components shall be maintained.
11. The tenderer shall furnish a certificate of guarantee to assure that any item having manufacturing defects or any other flaws in overall dimension precision etc. whatsoever detected during or after their actual use infields, the supplier will arrange free replacement by similar item, free from defects, the decision of the indenter in this regard will be binding.
12. The tenderer will be responsible for the stores being sufficiently and properly packed for transport by rail, road so as to ensure them being free from loss or injury on arrival at their destination. The packing of the store shall be done by and at the expense of the tenderer.
13. Tax and other elements: It should be specifically stated whether sale tax/ Packing/delivery/insurance charges etc are payable in addition to the amount quoted. If so price may be mentioned otherwise the price quoted will be assumed to be all inclusive and no separate tax or any charges will be paid in the event of the offer is being accepted.
