Special Conditions:

The tender form is available from the Director, Directorate of Mining and Geology, Kesavadasapuram, Pattom Palace P.O., Thiruvananthapuram -695004 after remitting the cost of tender form in cash, demand draft on all working days between 10.15 hrs to 17.15 hrs. till 27/08/2025. The tenderer who downloaded the tender form should submit the required tender value as a demand draft along with the tender.

Earnest money deposit (EMD) should be enclosed as demand draft drawn in favour of "The Director of Mining and Geology", payable at Thiruvananthapuram, and the same shall be enclosed in the tender application form. The name of the firm and tender should be mentioned in the reverse side of the EMD. All tenders received without EMD will be rejected. The firms which are exempted for furnishing EMD should produce a copy of relevant authorised document along with the tender for verification.

The rate quoted should be firm and valid till 31-03-2026 and the prices quoted should be inclusive of all levies and taxes. The envelope containing the tender should bear the subscription "Tender of Certified Reference Material" and should be addressed to the Director, Directorate of Mining and Geology, Kesavadasapuram, Pattom Palace P.O., Thiruvananthapuram -695004

Last date of receipt of tender is 15.00 hrs on 28/08/2025. Late tender will not be accepted. The tenders will be opened on 29/08/2025 at 15:00 hrs in the presence of tenderer or their authorised representative who may be present at that time. If the last date of tenders or the opening date of the tenders declared as Holiday, then the same will be postponed to next working day.
